

SUMMARY ANNUAL REPORT

For HOAG SHELTERED SAVINGS PLAN

This is a summary of the annual report for HOAG SHELTERED SAVINGS PLAN, EIN 95-1643327, Plan No. 005, for period January 01, 2011 through December 31, 2011. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$24,901,144. These expenses included \$469,375 in administrative expenses, \$24,428,877 in benefits paid to participants and beneficiaries, and \$2,892 in other expenses. A total of 5,483 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$311,084,649 as of December 31, 2011, compared to \$299,648,571 as of January 01, 2011. During the plan year the plan experienced an increase in its net assets of \$11,436,078. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$36,337,222, including employer contributions of \$14,316,438, employee contributions of \$19,570,304, earnings from investments of (\$1,236,792), and other income of \$3,687,272.
